



**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
UNIVERSITY OF COMILLA UNIVERSITY, CUMILLA, BANGLADESH.  
SELCUK UNIVERSITY, KONYA, TÜRKİYE**

**1. PURPOSE**

In accordance with a mutual desire to promote institutional cooperation, the parties have come together to collaborate in the areas specified within the scope of this protocol about education and research.

**2. PARTIES**

The parties to this bilateral agreement are Selçuk University (SU) and Comilla University (CoU).

**3. SCOPE**

Both parties agree to the following general areas of interest and cooperation:

- 3.1. Exchange of faculty members for lectures and short term visits,
- 3.2. Exchange of students for academic study,
- 3.3. Exchange of students and post-doctoral fellows to conduct basic scientific research,
- 3.4. Invitations to scholars for participation in conferences and symposiums,
- 3.5. Exchange of information, academic and research materials, publications,
- 3.6. Development of video conference links,
- 3.7. Planning for joint exploration of national and international funding opportunities to accomplish the aims of cooperative agreements between institutions,
- 3.8. Planning the joint/dual diploma program,
- 3.9. Exploring opportunities for the establishment of joint research centers,
- 3.10. Exploring opportunities for internships and field studies,
- 3.11. Planning for e-learning platforms.

**4. OBLIGATIONS OF THE PARTIES**

- 4.1. The parties will provide all necessary cooperation and support in accordance with the purpose of this protocol.
- 4.2. For informing and guiding students and academic staff, the parties are responsible.



## 5. AMENDMENTS AND DISPUTE RESOLUTION

Amendments to this protocol will be valid upon mutual written consent of the parties. Any disputes arising between the parties will be discussed initially between them; if they are unable to reach an agreement, the parties will proceed to termination.

## 6. VALIDITY AND TERMINATION

This protocol will become effective on the date of signature and remain in effect for a period of 10 (ten) years. Either party has the right to terminate this protocol by providing written notice to the other party 3 (three) months in advance.

## 7. OTHER PROVISIONS

- 7.1. The processes for implementing the items specified in the scope are subject to additional protocols.
- 7.2. As used in this protocol, "exchange" does not imply a specific ratio and implies no financial obligation by the receiving institution.
- 7.3. Both parties concur that all financial arrangements necessary to implement this protocol or any subsequent agreement must be negotiated according to the regulations of each university and depend upon the availability of funds.
- 7.4. Both parties recognize that this protocol establishes a foundation of mutual understanding and interest and does not in itself impose any financial obligations on either university.
- 7.5. This protocol has been prepared in both Turkish and English; and they are equally valid.
